

# Information notice pursuant to Articles 13-14 of the GDPR 2016/679 (General Data Protection Regulation)

Dear Sir/Madam,

Pursuant to Art. 13 of EU Regulation 2016/679 and in relation to the information that will come into our possession, for the purposes of protecting individuals and other subjects regarding the processing of personal data, we inform you of the following:

### 1. Purposes of Processing

The data you provide will be used for the purpose of providing you with assistance and information on SunSeed branded products.

#### 2. Methods of Processing

The methods by which personal data will be processed include both manual and electronic tools, in compliance with all necessary precautions to ensure the security and confidentiality of the information.

#### 3. Provision of Data

## 4. Communication and Dissemination of Data

The data provided will not be subject to communication or dissemination.

#### 5. Data Controller

## 6. Rights of the Data Subject

At any time, you may exercise, pursuant to Articles 15 to 22 of EU Regulation no. 2016/679, the right to:

- a) request confirmation of the existence or otherwise of your personal data;
- b) obtain information about the purposes of the processing, the categories of personal data, the recipients or categories of recipients to whom the personal data have been or will be communicated and, where possible, the storage period;
- c) obtain the rectification and erasure of data;
- d) obtain the restriction of processing;
- e) obtain data portability, i.e., receive it from a data controller, in a structured, commonly used and machine-readable format, and transmit it to another data controller without hindrance;
- f) object to the processing at any time and also in the case of processing for direct marketing purposes;
- g) object to an automated decision-making process relating to natural persons, including profiling.
- h) ask the data controller for access to personal data and the rectification or erasure of the same or the restriction of processing concerning you or to object to their processing, in addition to the right to data portability;
- i) withdraw consent at any time without prejudice to the lawfulness of the processing based on the consent given before withdrawal;
- j) lodge a complaint with a supervisory authority.
